# Office Package Insurance Program



## Insurance coverage for not-for-profit organizations that is:

- Affordable
- Comprehensive
- Expandable

The importance of having insurance coverage for volunteers cannot be overstated. Volunteers are the lifeblood of not-for-profit organizations. By protecting volunteers, not-for-profit organizations protect their most valuable assets, as well as their organization's reputation and long-term viability.

*The anniversary date is March 31st of each year. Organizations can join at any time during the policy year. Each participant is issued a certificate of insurance outlining the coverage and limits.*

### Does your not-for-profit organization need Office Package Insurance?

If your not-for-profit organization could be seriously affected by a third-party lawsuit or the loss of office equipment, then it needs insurance coverage. With the proper insurance, your Board of Directors can be secure knowing that your organization's objectives will stay on track. At just \$625 a year, Aon makes protection affordable.

### What does Aon's Office Package Insurance cover?

Office Contents provides all risk coverage for the property owned by your organization against such things as fire and theft for up to \$50,000. Commercial General Liability provides coverage if your organization is sued for bodily injury or property damage by a third party for up to \$2,000,000 and volunteers are also covered by this policy. For just \$625, your organization can do more with less.

### Are we eligible?

This insurance applies to all types of not-for-profit organizations including clubs, associations, societies, leagues, committees and charities (with few exceptions) that are members of Volunteer Canada.
